Our Mandate

The National Environment Service (NES) is a Government Statutory Agency mandated under the Environment Act 2003. It is established to protect, conserve and ensure the Cook Islands environment is managed sustainably.

Our Core Functions

To protect, conserve and manage;

- sustainable use of natural resources:
- · wildlife, in particular protected species;
- · designated areas of the Cook Islands waters;
- pollution of air, water, and land;
- damage to any beach, land, internal & inland waters, drain, building, market place and public spaces;
- safe disposal of toxic chemicals and wastes.

To monitor and evaluate activities that significantly affect the environment.

To enforce the Environment Act 2003 & Regulations.

To implement conventions and treaties related to the environment.

To provide secretarial services to each Island Environment Authority.

NES launches its communication goals and strategies

NES is launching its communication plan and tools in a concerted effort to strengthen its communication, public awareness and education programmes to its key stakeholders and the public. From climate change to biodiversity conservation, environment affairs are matters concerning everyone, everyday. Communication of strategic messages and raising public awareness to change social behaviours and attitudes towards the environment, will shape the way we see and treat the pristine nature of the Cook Islands.

NES acknowledges that environmental communication is an essential tool for action. As part of the launch, NES released its Environmental Communication Strategy (ECS) 2022-27. It outlines how NES will deliver a comprehensive package that will advocate for environmental policy and planning. The ECS 2022-27 underpins all its communication work in six main goals:



GOAL 1: PLANNING - Identify target audience, message and brand guidelines.



GOAL 4: ASSETS - Develop a suite of new assets or communication tools: website, social media, videos, surveys and electronic direct mail (eDM).



GOAL 2: CAPACITY - Introduce new Communications position, working groups and training & development for NES staff.



GOAL 5: OUTREACH - Ensure communication reaches all NES stakeholders, particularly members of the public and the Cook Islands community.



GOAL 3: CONTENT - Develop new content across various platforms e.g. NES 2.0 survey, factsheets, website and upcoming legislation and national policy.



GOAL 6: CONNECT - Connect the linkages between the environment and people through communications e.g. materials in Cook Islands Maori and include traditional practices.



New factsheets to help build public awareness

A total of sixteen factsheets were released by NES to build public awareness on areas relating to key activities. The factsheets are designed in a way that is simple for public use. It is based on four main groups:





NES2.0 National Environment Survey results released

The National Environment Survey, or NES 2.0, was a precursor to the launch of NES's communication plans and tools. The online survey was designed to gauge the views of the local community and help strengthen NES's performance as a Government agency, collect baseline data and mobilise the broader environment sector.

A total of 447 participants completed the survey – 87% from Rarotonga, 10% Pa Enua and 3% Other. Approximately 59% were women and 41% male, and roughly 77% of participants were Cook Islanders with 47% from the private sector and 49% holding a tertiary or university qualification.

The survey also obtained data on how NES's performance is perceived as a Government agency. Only 48% know some or a lot of NES's work and just 67% think that public awareness is satisfactory or better. Participants are mostly familiar with NES's work relating to waste management and biodiversity. There is significant room for NES to improve its communications and public awareness programmes.





The top priority areas highlighted by survey participants as to where NES should focus its efforts in the next 5 years include: Littering and Plastic Waste, Solid & Hazardous Waste, Protection of Biodiversity, Marine Pollution and Climate Change. The findings will be used for environment policy and legislation development.

The training of NES staff to administer the website is a key objective of the website development project.




